CONDITIONS OF ENTRY

1. I have read the description and information relating to the event being entered, and understand the physical nature of the sport of clay target shooting.
2. I am licensed to be in possession of a firearm for the sport of clay target shooting.
3. I am a current member of the Australian Clay Target Association.
4. I am familiar with and will comply with the rules of clay target shooting.
5. I am familiar with and will comply with the requirements of the safe handling of firearms.
6. I understand the necessity to comply with all lawful directions, including any safety directions, given to me by the organisers and other authorised persons and undertake to do so.
7. I understand that I have a duty of care to other competitors and to other persons who are attending the event. I will not deliberately or negligently endanger the life or safety of any other person while I am attending.
8. I do not have any medical condition or impairment that will endanger me or any other person if I participate. If I become aware of any such medical condition or impairment, I will notify the event organisers and I will withdraw from the competition.
9. Nominations will close at the Shoot Marshal or Tournament Director's discretion.
10. Payment of the nomination fee only entitles the shooter to enter the event.
11. Each shooter is to take enough cartridges to shoot the entire event.
12. Shooters who fail to be at their squad on time will be required to shoot at a time suitable to management.
13. Should a shooter being late for their squad then elect to withdraw from the event, they will not be eligible for any refund of nominations paid.
14. All shooters must sign the score sheet at the completion of each event. Once a shooter has signed the score sheet they have accepted the score. Any score sheet not carrying the shooter's signature will be credited with the lowest score recorded.
15. Any competitor will be called upon to referee and/or score throughout the period of competition. The persons designated to referee and score must fulfill their obligation to do so. Failure to either referee or score will incur a penalty of the LOSS OF ONE TARGET in the next event. Should a following event not be programmed then the penalty of the LOSS OF ONE TARGET will be incurred in the event concerned.
16. Any unauthorized shooter interfering with or attempting to interfere with the trap will be penalized FIVE (5) TARGETS.
17. All disputes must be in writing together with a \$20 deposit, which is refundable subject to the appeal being upheld.
18. All disputes and deposits (\$20) must be lodged with the Shoot Marshal or Tournament Director, who shall arrange a hearing with the appointed jury.
19. When team selection is involved, shooters who are eligible for the open team selection as well as section teams shall choose in which team they will be selected.
20. Any eligible competitor paying full nominations is entitled to receive awards in the Open Section.
21. A minimum of three persons must compete in any Grade or Section, including High Gun, before sashes, medals trophies and/or cash are awarded, irrespective of nominations paid.

22. I acknowledge that all events will be shot to completion under lights if necessary.
23. An acceptable standard of dress is required for all competitors, the Shoot Marshal or Tournament Director to adjudicate.
24. I acknowledge that the organisers will be taking photographs during the event and I consent to the usage of my image for the promotion of the Association and the Sport of Clay Target Shooting.
25. I acknowledge that participating in this event that I do so at my own risk. I accept all such risk and release the NTCTA Inc. (its officials, agents, employees, volunteers and any other person –including shooting range officials-authorized by the NTCTA Inc.) from all claims, demands and proceedings arising out of or in connection with my participation in the event and I agree to indemnify them against all liability for any and all personal injury, loss or damage caused to me which arises out or in connection with my participation in the event however arising.
